### **AMERICAS (including Canada and Brazil)**

#### **Brazil**

##### **What are Autodesk's standard payment terms in Brazil?**

Autodesk's standard payment terms in Brazil are net 30 from invoice date. Beginning August 1, 2011, standard payment terms for Blue Ridge Numerics customers located in Brazil will be net 30 from invoice date.

##### **In what language and currency are customers in Brazil charged?**

Blue Ridge Numerics customers in Brazil will be invoiced in English and billed in USD.

##### **What type of payments does Autodesk accept in Brazil?**

Autodesk accepts payments in the form of wire transfer in Brazil. Blue Ridge Numerics customers located in Brazil will need to use wire transfer as their form of payment.

##### **Does withholding tax apply to customers in Brazil?**

Customers in Brazil should withhold the appropriate amount of withholding tax from their payment beginning August 1, 2011 if required by law.

#### **Canada**

##### **What are Autodesk's standard payment terms in Canada?**

##### **Does Autodesk charge sales tax in Canada?**

Yes, Autodesk charges PST (outside Quebec, where applicable) or QST (in Quebec) and GST on sales in Canada. Beginning August 1, 2011, all Blue Ridge Numerics customers in Canada will be charged the applicable Canadian sales taxes.

The intent is to have these partners in place by August 1, 2011, but it may take longer than this in some countries. In case that no partner appears on [www.autodesk.com/reseller](http://www.autodesk.com/reseller) or you are not located in these territories, please consult the attached contact list which contains contact details for the Autodesk CFdesign product line.

### **Austria, Belgium and Germany**

#### **What are Autodesk's standard payment terms in Austria, Belgium and Germany?**

Autodesk's standard payment terms in Austria, Belgium and Germany are net 30 from invoice date. Beginning August 1, 2011, standard payment terms for Blue Ridge Numerics customers located in Austria, Belgium and Germany will be net 30 from invoice date.

### **Will customers in Denmark, Ireland, the Netherlands, Switzerland and the United Kingdom be responsible for paying Customs Duties?**

Blue Ridge Numerics customers in Denmark, Ireland, the Netherlands and the United Kingdom will not be responsible for paying Customs Duties; however customers in Switzerland will be responsible for paying Customs Duties. The reason for this is that Autodesk Distribution Centers are located in the U.S., Ireland, Russia and Singapore. As a result some customers ordering product outside of those locations are in fact importing product into their country.

### **Finland, Norway and Sweden**

#### **What are Autodesk's standard payment terms in Finland, Norway and Sweden?**

Autodesk's standard payment terms are net 30 from invoice date in Finland, Norway and Sweden. Beginning August 1, 2011, standard payment terms for Blue Ridge Numerics customers in Finland, Norway and Sweden will be net 30 from invoice date.

#### **In what language and currency are customers in Finland, Norway and Sweden charged?**

Blue Ridge Numerics customers in Finland, Norway and Sweden will be invoiced in English and billed in either Euros or SEK.

#### **What type of payments does Autodesk accept in Finland, Norway and Sweden?**

Autodesk accepts payments in the form of wire transfer and cheque in Finland, Norway and Sweden. Blue Ridge Numerics customers located in Finland, Norway and Sweden will need to use wire transfer or cheque as their form of payment.

#### **What taxes are customers in Finland, Norway and Sweden charged?**

Autodesk does not charge VAT to business customers in Finland and Norway who have local VAT registration. Autodesk will charge 25% VAT to Blue Ridge Numerics customers in Sweden. Autodesk may also charge withholding tax in some cases.

### **France**

Autodesk's standard payment terms in France are either net 45 from invoice date. Beginning August 1, 2011, standard payment terms for Blue Ridge Numerics customers located in France will be net 45 from invoice date.

#### **In what language and currency are customers in France charged?**

Blue Ridge Numerics customers in France will be invoiced in French and billed in Euros.

#### **What type of payments does Autodesk accept in France?**

Autodesk accepts payments in the form of wire transfer and cheque in France. Blue Ridge Numerics customers located in France will need to use wire transfer or cheque as their form of payment.

#### **What taxes are customers in France charged?**

Autodesk charges 19.6% VAT to customers in France. Autodesk may also charge withholding tax in some cases.

#### **What type of payments does Autodesk accept in Italy?**

Autodesk accepts payments in the form of wire transfer and cheque in Italy. Blue Ridge Numerics customers located in Italy will need to use wire transfer or cheque as their form of payment.

Blue Ridge Numerics customers in Eastern Europe will be invoiced in English and billed in Euros.

#### **What type of payments does Autodesk accept in Eastern Europe?**

Autodesk accepts payments in the form of wire transfer and cheque in Eastern Europe. Blue Ridge Numerics customers located in Eastern Europe will need to use wire transfer or cheque as their form of payment.

#### **What taxes are customers in Eastern Europe charged?**

Autodesk accepts payments in the form of wire transfer in Australia. Blue Ridge Numerics customers located in Australia will need to use wire transfer as their form of payment.

### **What taxes are customers in Australia charged?**

Blue Ridge Numerics customers in Australia will be charged 10% GST.

### **India**

Autodesk includes applicable GST tax on their invoices if the deliver to address is in Singapore. Beginning August 1, 2011, invoices sent to Blue Ridge Numerics customers in India with a deliver to address in Singapore will also include applicable GST.
